

Privacy Policy

Your privacy is important to us. This privacy policy explains what personal data Rent Ads collects from you, through our interactions with you and through our services, and how we use that data.

Personal Data

- Rent Ads collects data to operate effectively and provide you the best experiences with our services. You provide some data directly, such as when you create a Rent Ads account, post an advertisement, register for an event, or contact us for support. We get data by recording how you interact with our services, for example, using technologies like cookies, and receiving error reports or usage data from software running on your device.
- Rent Ads collects non-personally-identifying information that web browsers and servers typically make available, such as the browser type, referring site, and the date and time of each visitor request. Rent Ads purpose in collecting non-personally identifying information is to understand how visitors use its website. From time to time, Rent Ads may release non-personally-identifying information taken together, e.g., by publishing a report on trends in the usage of its website.
- Rent Ads also collects potentially personally identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments.
- We may also obtain information about you from other sources. For example, if you create or log into your Rent Ads account through a social media service (like Google, or Facebook) or if you connect your account to a social media service through our publicize feature, we will receive information from such service (such as your username, basic profile information, and contacts) via the authorization procedures used by that service. The information we receive depends on which services you authorize and any options that are available.

How We Use Personal Data

- Rent Ads uses the data we collect to operate our business and provide you the services we offer, which includes using data to improve our services products and personalize your experiences. We also may use the data to communicate with you, for example, informing you about your account, security updates and product and services information. We use data to help show relevant advertisement, whether in our own products and services or in products and services offered by third parties.
- If you are a registered user of Rent Ads and have provided your email address, Rent Ads may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what is going on with Rent Ads and our products.

When we share personal data

- We share your personal data as necessary to complete any transaction or provide any services you have requested or authorized. We may also share data with vendors working on our behalf; when required by law or to respond to legal processes or government requests, to protect our customers; to protect lives; to maintain the security of our services and to protect the rights or property of Rent Ads.

How to Access & Control Your Personal Data

- You can view, edit, or delete your personal data online for Rent Ads. You can always choose whether you wish to receive promotional email, SMS messages, telephone calls and postal mail from Rent Ads.

Cookies Policy

- Rent Ads uses cookies (small text files placed on your device) and similar technologies to provide our websites and online services and to help collect data. Cookies allow us, among other things, to store your preferences and settings; enable you to sign-in; provide interest-based advertising; combat fraud and analyze how our websites and online services are performing. Rent Ads apps may use other identifiers for similar purposes.
- The only personal information a cookie can contain is information you supply. A cookie cannot read data off your hard drive. Our advertisers may also assign their own cookies to your browser (if you click on their ads), a process that we do not own or control.
- Rent Ads uses cookies to help identify and track visitors, their usage of Rent Ads website, and their website access preferences. Rent Ads visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Rent Ads websites, with the drawback that certain features of Rent Ads websites may not function properly without the aid of cookies.

Data Security

- Rent Ads discloses potentially personally identifying and personally identifying information to its employees, and contractors and affiliated organizations that (i) need to know that information in order to process it on Rent Ads behalf or to provide services available at Rent Ads, and (ii) that have agreed not to disclose it to others. Rent Ads will not rent or sell potentially personally identifying and personally identifying information to anyone. Rent Ads may share user account details with third parties to conduct market research and provide other services of interest. Rent Ads takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally identifying and personally identifying information.
- We have implemented measures designed to secure your personal information from accidental loss and from unauthorized access, use, alteration and disclosure.
